    - 6. Chief Brocato made a motion to approve the revised Bylaws and it was seconded by Chief Botting
    - 7. There were no objection to approve FCABC Bylaws; Motion passed

- 1. CERT: Chief Caruso, BSO Fire Rescue/Cooper City
  - a. CERT antenna installation continues to move forward; update provided
  - b. FLL still looking for CERT volunteers for the vaccination sites
  - c. Vaccination Survey sent to the members by Chief Caruso

#### 2. MUTUAL AID COMMUNICATIONS - Chief Levy, Lauderhill Fire Rescue

- a. Zetron system to be decommissioned by September 2021
  - Will be maintained as long as possible until then unless there is a catastrophic failure
- b. P36 numbers were forwarded out from Regional communications for almost a one-year period
- c. Tracy Jackson gave update on 16<sup>th</sup> Tower site in Hollywood for the Regional Communications System
- Dealing with the City of Hollywood has been very positive
- Projected cost and timeframe from Motorola being discussed
- d. BSO is sponsoring a Multi-Agency/Multi-Discipline drill at the end of June which will involve an MCI component and usage of ReadyOp Patient tracking.
- e. Closest Unit Response (CUR)-Phase 1A, Lauderhill, Sunrise and Tamarac will be moving forward to increase the CUR travel time from 2-4 minutes, Scheduled for 3/15.
- f. Discussion on USDD maintenance and service, discussion to have the FCABC sponsor a 2-day class for USDD to come in and provide training to agencies to service and maintain their own system from the ATX to all accessories within the fire station. This matter will be further discussed at the next month's meeting discussion.

  - a. The FTFC awards nominations are due by 5/1
  - b. Presentation of Coral Springs Broward Health
  - c. County Bariatric unit discussed

- d. Dr. Roach's EMS Website with Protocols and EMS Subcommittee information is available
- e. FLFR has shown a decreased of calls; looking into any trends; feedback is welcomed from other agencies
- f. Chief Downey congratulated Chief Shaw on his recent promotion

- c. Training on WebEOC, Rapid Impact Assessment and vulnerable population registry is underway
- d. Update on NGO entity on how Cities can get credentials to be more standardized on functions to assist with the vulnerable populations
  - Kimberly requested for more clarification on this matter from the County
  - Tracy Jackson updated on this matter and was not in favor of the NGO entity initiative
- e. Update on Emergency Coordinator Counsel, Bylaws and Sunshine Law
  - More discussion will be held at next ECC meeting

#### 5. FIRE PREVENTION: - Chief Bowers, Coral Springs Fire Rescue

- a. A new subcommittee on Public Education was formed and the first meeting is next week
  - This subcommittee will be reporting to the FP Subcommittee
- b. Chief Demopoulos completed a survey on Knox Boxes and key secures
  - Researched on this matter was completed
  - Quotes obtained; 50% discount from the vendor offered
  - There are grants available but Chief Demopoulos asked for direction on how to proceed
  - Chief Lucas commented that this will be a Countywide Grant and a decision on which agency will assume responsibility on the Grant will be needed; discussion held
  - Chief Downey asked Chief Demopoulos to write a proposal on the cost and which agencies will be participating
  - Survey results will be forwarded to Chief Downey

- a. RDSTF working group Region 7 meeting was held to coordinate training classes
- b. Update on upcoming training classes happening in April
