- 1. Today, 757 days of EOC activation for COVID response—Level 2. Currently, under a Local State of Emergency. Will notify all parties when ceases.
- 2022 Annual State Exercise hazard is Cyber Security. County will be conducting a drill with in-person and virtual components concentrating on communications redundancy during a cyberattack. County exercise will be conducted on Monday, April 25, 2022@ 09:00
- 3. State requesting information on Statewide Mutual Aid Agreements with jurisdictions. Information requests were sent out from EOC MSB for SMAA agreements a. Disaster Recovery Center possible sites for identification
- 4. Several Position-Specific courses are being offered in Region 7
