 - 1. Broward County has provided Coral Springs with a verbal commitment to test the HUB dispatch CAD solution
 - 2. The HUB allows disparate CADs to communicate
 - 3. If a caller places a call to 911 in Coral Springs for an address in Tamarac, the call would be entered into Coral Springs CAD and automatically routed to a county dispatch console for proper unit dispatch
 - 4. This is a great step forward and once the HUB solution is in place, we can participate in closest unit response
